

# An Interview of Excellency Mr. Adam Mulawarman Tugio, Ambassador of Indonesia to Pakistan



Syeda Wajida Saleem, Chairperson Diplomatic Affairs Committee of Islamabad Chamber of Small Traders & Small Industries conducted an exclusive interview of Excellency Mr. Adam Mulawarman Tugio, Ambassador of Indonesia to Pakistan. Major focus of the interview was the need for improvement in bilateral trade between both the brotherly countries being the largest Islamic populations of the world. Mr. Tugio shared his invaluable insights and recommendations for enhancing trade and cutting down on trade deficits. He also highlighted the potential areas of bilateral trade as well as shared his opinions about the commonalities both the countries share in terms of culture, food, music and religion.

Question: Excellency, I represent Islamabad Chamber of Small Traders & Small Industries (ICSTSI) therefore a representative of SMEs Chamber of commerce. Coming from that position we see a lot of untapped potential of SME sector bilateral trade between Pakistan & Indonesia. How can we improve in this area?

Mr.Tugio: I believe its high time that governments all over the world understand the pivotal role SMEs play in

the economy of any country and Pakistan and Indonesia are no exception. SMEs tend to lag behind in terms of modern business techniques due to lack of awareness and resources but today is age of digital economies and SMEs must be integrated to that in order for them to survive modern day economic challenges.

Another best way to promote SMEs is to promote "Made in Pakistan" and "Made in Indonesia" products across both borders with special quota allocations for the SMEs which would give them global market access via support they require at policy level.

Question; Pakistan and Indonesia are world's largest Muslim populations countries who have recently signed a Preferential Trade Agreement and it has helped the trade volumes jump from US \$ 1 Billion to US \$ 4.5 Billion. Excellency with such a great response to this agreement, shall we now opt for Free-Trade Agreement?

Indonesia has huge potential in exports of palm oil as it comprises of over 76% of its exports, second is coal which comprises about 6-7% of Indonesian exports and

rest are miscellaneous small goods. Pakistan on the other hand has export potential in pharmaceuticals, surgical goods, textile and agricultural products. In that regard both countries have export potentials that could be mutually beneficial and therefore we are diligently working hard to expand this potential of bilateral trade.

Question: Excellency, Pakistan can become a gateway for Central Asian Republic States for Indonesia whereas Indonesia can give access of ASEAN block to Pakistan. Do you see if both the countries can capitalize upon the geographical positions of each other for trade and investment opportunities? Additionally, do we need to develop banking channels between Pakistan and Indonesia for creating business opportunities?

Indeed, we not only see this potential of geographical optimization as an opportunity but we are keen to invest in CPEC projects as our government sees the future opportunities that lie ahead. We also engage chambers of commerce like yourself for promotion of the trade shows and trade expos that are held back in Indonesia as well as in Pakistan thus facilitating B2B connections. Pakistan currently has a trade deficit with Indonesia and needs to diversify its exports basket.

Question: Pakistan imports most of its spices from Indonesia therefore we owe our taste to Indonesia for that matter and are grateful for that too. Yet, Pakistan being an agricultural country itself must be able to produce its own spices. What do you think could contribute to make this possible?

I am very thrilled by your question as spices are a subject of my interest and I have even written a book on the same topic. The reason I see as a contributor towards failure of Pakistan to produce its own spices is that Pakistan is still importing the basic ingredients of its spices. For instance, let's talk about "garam masalah" which is a combination of number of spices and Pakistan is importing number of its ingredients.

Second reason is that Pakistan is not fully taking advantage of exports opportunities that exist internationally. There are large sums of Pakistani expats in various parts of the world who can be a market for export of such spices.

Question: Excellency, few questions towards lighter side please. How would you describe your stay in Pakistan and do you see any similarities in terms of food habits, cultural norms and so on?

Glad you asked that question. When I landed at Islamabad from London in November, I was taken by surprise as Islamabad was colder than I had expected. The city was green. I take great pleasure in taking a walk with my wife in Jinah Park and it's such a calm and serene experience for me. We share similar food taste inclining towards spices.

I must say that I am very impressed with the working environment of Pakistan as people are thorough professionals and hardworking. The schooling system and the "Think-Tank" in Pakistan are par excellence.

Conluding Remarks: Excellency, we thank you for your precious time today and for the kind sentiments and encouraging remarks about Pakistani community. We feel same about our Indonesian brothers and sisters. We find Indonesian citizens to be cultured, educated and peaceful community and its always a pleasure to come across a citizen of Indonesia. Thank you again.











# An Interview of Excellency Mr. Ahmad Ali Sirohey Ambassador of Pakistan to Niger



Interview was conducted by Syeda Wajida Saleem, representing Islamabad Chamber of Small Traders & Small Industries (ICSTSI) in the capacity of Chairperson Diplomatic Affairs Committee.

Question: Excellency, we are grateful for your time. Without wasting any time we shall proceed to Question one please. Government of Niger has been establishing Special Economic Zones (SEZs) lately. Are they finished with the process and how beneficial could these zones be for Pakistani business community?

There is dedicated Pakistani zone and its located 140 kilometers from Niger capital, Niamey located towards Kokowa. It's almost complete and shall be ready for working soon in my anticipation. This if taken advantage of can be very useful for Pakistani business community.

Question: Niger has medicines that are very costly whereas Pakistan has export potential in pharmaceutical industry. How can this opportunity be taken in to account by Pakistani Pharma companies?

I need to make one thing very clear here that Niger has no industry at all, be it medicines, shoes, garments, textiles, uniform factories, sugar mills, and so on therefore the opportunities are not limited to pharmaceutical sector but exist in all these areas. There is only one pharmaceutical company at Niger right now whereas the need is beyond 40 pharma companies. Bangladesh focused upon its textile industry and has proved to the world its potential.

Niger is member of Economic Communities of West Africa block which consists of 15 states of Africa. Niger has free access to all these 15 African states. Additionally, from last year Africa Continental Free Trade Zone has been operational so whatever is "Made in Africa" will have no tariff on it so Pakistani SMEs can take big advantage of that. Therefore manufacture in Africa and sell in Europe, US and Canada with free access to all these markets.

Question: Government of Pakistan has launched "Look-Africa-Policy" how fruitful do you think this policy initiative

will prove for trade and investment in Africa?

To tell you the truth, diplomacy cannot work without support from the government and its concerned institutions. When I got appointed at Niger, we had almost lost it to India but with my persistent hard work and efforts I built a very good liaison for Pakistan with the Niger government so much so that they awarded me with "Best-Ambassador-Award" consecutively for years 2021-22. They also declared me Honorary Consulate General of Niger to Pakistan. I foresaw great future of Pakistani businesses here at Niger and wrote to various ministries and institutions in Pakistan to spread the word, hold exhibitions and trade fairs so that awareness is created about such untapped investment opportunities but to my sad surprise I proved to be one-man-army. I never got the needed support and therefore could not fulfill the intended goals.

Question: Excellency, whenever we try to promote business opportunities existing in Africa through platform of Islamabad Chamber of Small Traders & Small Industries (ICSTSI) we get one common response, the long distances and higher freight costs. How can we address this valid issue?

Please note that India are doing great at Niger and of course the distance calculations are same almost. At a first step shipping lines need to be engaged, develop culture of shared containers as clearance cost is same for both India and Pakistan. Third and last, send semifinished goods that should be assembled at Niger which shall save a lot in terms of cost.



Question: Excellency, you had a dream of establishing a "Pakistan Trade House" at Niger where Pakistani businesses shall be able to showcase their products and services and shall get right connections for investment. How far is it from completion and what role can (ICSTSI) play in its promotion?

Yes, it was my dream and the idea was to get just one time subsidy and later the trade house shall market itself. Unfortunately, again the concerned institutions showed their back and still there was no support from the government. Therefore, now Turkey is working on same lines but we could not materialize the project and my tenure here at Niger is almost over. I hope and pray that it gets revitalized in future.

Question: Excellency, Pakistan has great tourism potential as we have the sites for archeological, religious and adventure tourism but still we fail to get the decent number of tourists in Pakistan. Where are we lacking and how can we improve in this area?

I am glad you asked this question as I can talk about Pakistan's tourism potential for hours and yet we shall have room for more to add on. Pakistan has four seasons, green deserts, valleys, rivers, lakes, and forts, archeological sites of religious importance for Buddhist, Hindu and Sikh communities yet we fail to attract these potential tourists. We have 24 rivers, we have 36 lakes and highest peaks in the world. With such diverse mix of tourism destinations, if we fail to attract the decent number of tourists it's a moment of worry and pondering.

Excellency, you yourself are an author of repute on issues of diplomacy and economy. Which books and authors are close to your heart?

My most favorite book is Al-Raheeq-ul-Makhttom by Saif-ur-Rehman Mubarakpuri which is a beautiful work of art on biography of Prophet Muhammad (pbuh). My second favorite book is Extreme Economies by Richard Davies and third favorite is Diplomacy by Henry Kbssinger.

Question: Excellency, in the end what message would you like to give to business community of Pakistan?

Very short message, in fact three words, Be Proactive, Innovate and Implement.

If we are dissatisfied and disgruntled at the attitude and overcharging of the seller or shopkeeper than our attitude and behavior towards our customer not be the same. Our prophet (PBUH) says none of you is true believer unless and until he wants for his brother what he wants for himself. Pinch yourself and feel how others feel.

As Muslim traders our responsibilities are much more than others. Our religion is very particular and emphasizes on fair trading. There are many verses in Quran-Kareem giving instructions and guidance for fair trading. For example verses no 81, 82 and 83 of Surah Al-Shuhara

181: Give full measure and cause no loss to others

182: Weigh with true and straight balance

183: Defraud not people by reducing their things nor do evil and making corruption in land.

In Surah-e-Rehman, Verse No.9

#### وَأَقِيمُواْ ٱلْوَزْنَ بِٱلْقِسْطِ وَلَا تُخْسِرُواْ ٱلْمِيزَانَ

"Weigh with justice and make not the balance deficient."

Our tragedy is that almost all the Muslims recite Qurankareem everyday but don't contemplate at its meaning. When we recite the above verse we earn 240 good/nobilities because there are 24 alphabets in this verse. So as ten good rectitudes per alphabet. On the other hand when we don't know the meaning and don't comply with it we make balance deficient. We commit sin and disobedience which ruine/destroys those 240 rectitude and much more.

In another Hadees Mubarak prophet ((PBUH) says a truthful and honest trader will be raised with the messengers, truthful and shuhada on the day of resurrection. Shuhada means people who laid down their lives in the cause of Allah.

Traders are backbone of national economy. This sentence has become a maxim or proverb because it is often spoken and written on many occasions in every regime but this is also a vivid fact that almost every government has tried to break this backbone. No trader's friendly government has ever been found in Pakistan. In every regime traders have been subjected to irrational system of taxation. No government has ever acknowledged the importance of traders. No government has ever granted the traders their due respect and honor.

## Role of SMEs in Economic Development of Vietnam

Small and medium-sized enterprises (SMEs) are considered to play a labor settlement role and are of great importance to economies of developed countries. SMEs contribute to the state budget through tax payments. SME sector employs the majority of the domestic workforce and is assessed as a channel to fulfill individual entrepreneurial aspirations.

In Vietnam, during the period 2010–2017, the SME sector accounted for about 98.1% of the total number of operating enterprises, contributed about 45% of GDP and 31% of the total state budget revenue, and created jobs for more than 5 million employees. The Southeast provinces (SE) were the most dynamic and developed economic regions in the country, accounting for about 40.9% of SMEs compared to the whole country in 2019. Therefore, the contribution of this SME sector to economic growth was not small.

In recent years, many studies have shown that small enterprises play a very important role in economic development and start-ups in the economy to motivate the socio-economic development of many countries around the world.

Particularly in Vietnam, the role of SMEs is increasingly recognized by society by making a significant contribution to the country's economy, with GDP accounting for about 45% of the country's total GDP, annually attracting more than 90% of new employees. Small enterprises are the backbone of the private sector, creating more jobs and contributing taxes to the government, and improving the infrastructure.

Most recently, SMEs were the key economic drivers of Southeast Asian countries in the period 2010–2019, accounting for 97% of the total number of businesses and 69% of the workforce. This business sector contributes an average of 41% of the GDP of the countries in the region. In Vietnam, household businesses accounted for 30% of MSME contribution and 12% of GDP in 2018.

#### SME and Entrepreneurship Support Programs in Viet Nam

The SME Development Fund and the Credit Guarantee Fund are useful policy initiatives. The government of Viet Nam fosters SME financing primarily through the SME Development Fund (SMEDF) and the Credit Guarantee Fund (CGF). Both are useful initiatives, but they experience low take-up. The SMEDF, delivered mainly through partnering banks, provides 80% of the loan

amount at interest rates capped below the market rates, with the borrowing company required to contribute 20% of the project cost. However, the first provision might discourage the participation of commercial banks by reducing excessively the profit margins on the SMEDF backed loans, while the second condition might deter cash-constrained small businesses from applying. Low awareness of the (SMEDF) among small companies and a long approval process have also been reported as reasons underlying the limited use of this fund.

Entrepreneurship education is in early stages, especially in primary and secondary education. The Ministry of Education and Training (MOET) has stated the importance of instilling the spirit of entrepreneurship in Vietnamese youth at an early age, but little progress has been made to integrate entrepreneurial learning at the primary and secondary levels of education. The government could consider creating a National Entrepreneurship and Education Commission, whose task would be to develop a strategic approach to entrepreneurial learning throughout all levels of the educational system.

#### Program Support for Women's Entrepreneurship

The National Strategy on Gender Equality 2011-2020 set a target to increase the share of SMEs owned by women to at least 35% by 2020 and instructed the various ministries to co-operate in the implementation of the strategy nationwide. In the past, government support for women's entrepreneurship has been limited. However, "Project 939" ("Supporting women in starting a business in the period 2017-2025"), launched by the government in mid-2017, is a sizeable initiative with ambitious targets for increasing the number of start-ups owned by women and reaching these start-ups with consultancy services. Going forward, with a view to mainstreaming women's entrepreneurship in national policies, the government could also ensure that women-owned enterprises are adequately represented in all incentives and programs within the scope of the SME Support Law.

#### (EVFTA) Agreement

The successful conclusion of the negotiation and the signing and ratification of the (EVFTA) Agreement has gone a long way with the efforts and high political determination of the Party, National Assembly and the Government of Vietnam. (EVFTA) is considered a comprehensive, high-quality and interest-balanced agreement for both Vietnam and the European Union.

The European Union will eliminate import duties on 99.2% of tariff lines after 7 years from the effective date of the (EVFTA) Agreement, equivalent to 99.7% of Vietnam's export turn-over. For the remaining 0.3% of export turn-over, the EU commits to give Vietnam tariff quotas in the quota import tax to 0%.



## New Markets & Bazars Enter Landscape of Islamabad



CDA has decided to set up a new weekly bazaar in D-12 and new fruit and vegetable markets in various residential sectors of Islamabad.

CDA Chairman recently directed the planning wing to identify sites for Sunday bazaar in D-12 and new small size markets for fruit and vegetables in various markets across Islamabad.

CDA Planning Wing has proposed weekly bazaar in D-12 for residents of D-12, E-11, Golra, Shah Allah Ditta and other nearby areas as the current bazaars of G-6, G-10, H-9 and I-9 are comparatively away from the areas.

Similarly, new small size markets, having four to five shops, solely for fruit and vegetables are being planned in various sectors including F-6, G-7, G-8, G-9, F-7 and F-8, etc. There would be no such market in G-6 as it already has weekly bazaar.

After setting up these markets, CDA will auction them. Basic purpose of setting up these markets was to provide fruit and vegetables to residents of Islamabad on cheaper rates. Besides, a weekly bazaar also exists in Bhara Kahu as well but had fallen in the alignment of the bypass road project. After completing the bypass project, a proper site will be allocated for this bazaar.

With the current expansion of the federal capital geographically as well as an increase in population requires more markets, more shopping options for smaller articles. The small local markets located almost in each sector are a big source of fulfillment of such needs but more such shops need to be added. With current trend of opening of category A and B businesses in smaller markets for rent savings is taking away the space from small shopkeepers which needs to go back to its original CDA model.

At the same time these small markets need cleaning and improvement in their environments so that families could feel comfortable shopping there. So far there is culture of shopping via domestic home helpers or men going and making these daily small purchases.

Parking is already a problem for Islamabad residents because of bad planning by the CDA. People regularly struggle to pass through large commercial centres such as Blue Area or F-8 Markaz, or find space to park in sectors' main markets.

CDA summary called for one additional storey for class three shopping centres, which are the smaller markets in each sub-sector. According to the city's original plan, these markets consisted of ground plus one storey, of which the ground floor was for commercial activity and the first floor for residential flats.

The CDA later allowed developers to construct commercial basements, and some business owners are even using the first floor, in violation of CDA rules, for commercial purposes. With the proposed by-laws, the CDA appears to be ready to allow two more floors for commercial activity. If the CDA is keen to turn the smaller markets into mini markazes with four storeys dedicated to commercial activity, it should also improve the old sewerage lines in these markets.


